Large Asian Merger

ACTG members acted for a large Chinese conglomerate in its acquisition of a Singapore-listed entity to create a sizable market player. Acting as the lead firm, Rajah & Tann, Lex Mundi member firm for Singapore, coordinated a review of over 90 merger control regimes worldwide by ACTG members (most of which were provided free of charge through the Lex Mundi Free Advice Policy) to assess whether the merger had to be notified. Member firms in Korea, Turkey and Germany were engaged to prepare and submit formal notifications to their competition authorities, while other member firms were retained to take part in informal discussions with their national authorities.

Nine Firms Cooperate for Billion Dollar Merger
